Speaker John Eickman, from HITS, said they have been doing the Triathlon since 2016 - 2019 with the race starting at Williams Lake as a swim, bike, and run. They have a little over 400 people register for the Triathlon with sporadic starting times. Mobile life will be on site with dive teams, EMTs will be at the finish line and their plans are to go above and beyond all COVID protocols. Finish line ceremonies will have everyone spaced apart. Approval letters from land owners, Police Department, and approval from Rosendale Highway for overflow parking at Binnewater Kiln have been handled. All documents will be forwarded to the Town Clerk via email to the Town of Rosendale.

Councilwoman Wykoff:

The Economic Development Committee is reaching out to other groups in reference to the Heart and Sole Program. There will be an information table at the Rosendale Farmers Market. Their next meeting is scheduled for Wednesday, June 16th at 5:30PM via zoom.

The Planning Board had two public hearings for a minor subdivision and special use permit that were passed. New business was a minor subdivision, but requests were made to keep this opened for more information to be reviewed at the public hearing scheduled for tomorrow, June 10th at 7PM.

RMC had issues with the Police Department air conditioning. Lowe Heating and Plumbing is doing service on the splits. The hot water heater will be hooked up this week and the State did their annual fire inspection.

The Grower's dinner is scheduled for take-out only from the Blackboard Bistro the weekend of the June 19th.

RVGA meetings will be in meeting room M-15 in July with the state mandated COVID-19 regulations.

In May for ZBA, there were two public hearings an area variance for Gristmill Road with requests to keep open, an area variance closed, old business moved forward to this month, and an area variance for 426 Main Street. The next ZBA meeting is scheduled for June 15th via zoom.

The Building Department fees collected totaled \$12,841.00 with 33 permits.

Councilman Igoe:

Highway is in the midst of paving season working off Marbletown and Rochester's roadwork and will share service through the month of July along with help from the Village and Town of New Paltz.

Project 1 in High Falls Park paving is complete.

The Highway Department vehicles are on the agenda tonight that will be taken care of.

The sewer bids came in a great deal higher due to COVID inflation so we will need to review finances and schedule another public hearing.

We only received half of the water surveys and ask our residents of the Town of Rosendale to return their complete surveys to the Water Department for our eligibility to be approved for the Hardship Financing.

Rosendale Sand Hill tank location will be purchased.

High Falls Water District is shutting down in four-day intervals to treat water for the chlorine treatments. The Ulster County Community College is drawing from 5 to 6 thousand gallons a day.

There was a four-month time table, up to the month of July, for the Rosendale Police Reform Report. The Police Department has a schedule for the Police Reform Committee that may be have it out in June at The Police Commission meeting.

Resolution 6-2021-#4 - Supervisor Walsh made motion that the Town Board of the Town of Rosendale hereby authorizes the purchase a new dump body and installation on a Town owned Cab and Chassis from the vendor of T & T Sales, Inc. for a price of \$38,243.00. 2nd by Councilman Igoe. Resolution 6-2021-#5 - Supervisor Walsh made motion that the Town Board of the Town of Rosendale hereby authorizes the Supervisor to sign the proposal with Underwater Solutions Inc. for the cost of \$3,690.00. This resolution is contingent upon a like resolution being passed by the Town Board of the Town of Marbletown. 2nd by Councilman Igoe. ROLL VOTE by Town Clerk; 4 Yes.

Resolution 6-2021-#8 - Supervisor Walsh made motion that the Town Board of the Town of Rosendale hereby approves DeWitt Mills Fence Company to replace the Rosendale Recreation Centers existing fencing around two dugout areas and re-install and secure the fencing at the tennis courts. 2nd by Councilman Igoe. ROLL VOTE by Town Clerk; 4 Yes.

Councilman Pryslopski said there was a public question asking why the town did not work on the fencing last year. Councilman Pryslopski said we had completed some work last year as well as sanding and painting the picnic sets with ongoing work at the Recreation Center. Supervisor Walsh also mentioned we did have limitations due to COVID-19 protocols allowing only so many workers at a time in locations where work needed to be completed.

Resolution 6-2021-#9 - Supervisor Walsh made a motion that the Town Board of the Town of Rosendale hereby authorizes the Supervisor to sign an agreement with the Rosendale Rapids Swim Team for Season 2021. Supervisor Walsh said the rates will be discussed. 2nd by Councilwoman Wykoff. ROLL VOTE by Town Clerk; 4 Yes.

Supervisor Walsh said the Bank of Greene County Bond was on the agenda, but we are following up on more information still needed.

Councilman Pryslopski stated a public comment from Jody Munson Brooks made mention of the low pay rates. Councilman Pryslopski and Supervisor Walsh stated the extensive efforts for budgeting and pay rates that were raised each year.
