## TOWN OF ROSENDALE TOWN BOARD MEETING October 05, 2022

Supervisor Walsh called the meeting to order at 7:01P.M. followed by the Pledge of Allegiance with a moment of silence observed for Robin Larsen.

**Correspondence** – The Town Board discussed concerns/complaints of a letter that was submitted by Mrs. Anderson. The Deputy Town Supervisor and Fire Marshal will be looking into the issue.

Supervisor Walsh made a motion to accept the resignation of Jamison Eisele effective 9/30/2022. Seconded by Councilman Havranek; ROLL VOTE 4 Yes.

Supervisor Walsh made a motion to accept the resignation of Steven Christiana from the position of Laborer Effective 10/7/2022 with approval to work per diem for 30 days for the purpose of training new staff, Seconded by Councilmember Wykoff; ROLL VOTE 4 Yes.

Supervisor Walsh made a motion to approve Erich Funiccus as a Temporary Non-Benefitted Full Time Police Officer for 90 days effective 10/18/2022. Seconded by Councilman Havranek; ROLL VOTE 4 Yes.

Supervisor Walsh made a motion to hire Dakoda Wagner as Police Officer at \$23.44 per hour for no more than 20 hours per week effective 10/5/2022. Seconded by Councilman Havranek; ROLL VOTE 4 Yes.

Supervisor Walsh made a motion to hire Joshua Hintz as HMEO (Highway Maintenance Equipment Operator) at \$19.00 per hour for no more than 40 hours per week effective 10/11/2022. Seconded by Councilman Havranek; ROLL VOTE 4 Yes.

Supervisor Walsh made a motion for the General Fund to lend the Scenic Byways Fund \$7,101.08 in anticipation of grant reimbursement. Seconded by Councilman Havranek; ROLL VOTE 4 Yes.

Supervisor Walsh made a motion to accept a \$1,000.00 donation from Don and Hella Beale for Rosendale Recreation Center. Seconded by Councilman Havranek; ROLL VOTE 4 Yes.

Seconded by Councilman Havranek; ROLL VOTE 4 Yes.

**Resolution 10-2022-#3** Supervisor Walsh made a motion that the Town Board of the Town of Rosendale hereby schedules a Public Hearing on November 2, 2022, at the Rondout Municipal Center, 1915 Lucas Avenue Cottekill, NY 12419 to consider accepting the 2023 Preliminary Budget. Seconded by Councilmember Wykoff; ROLL VOTE 4 Yes.

**Resolution 10-2022-#6** Supervisor Walsh made a motion that the Town Board of the Town of Rosendale hereby authorizes the Supervisor to sign the addendum of the Slotnick Signs contract for and additional \$500.00 to due to New York State Department of Transportation requirements for "crashworthy" Sign Posts. Seconded by Councilman Havranek; ROLL VOTE 4 Yes.

**Resolution 10-2022-#7** Supervisor Walsh made a motion that the Town Board of the Town of Rosendale hereby approves the purchase of a 2022 Smith 2 Yard Electric Sander from Chemung Supply company for \$8,525.00. Seconded by Councilman Havranek; ROLL VOTE 4 Yes.

**Resolution 10-2022-#12** Supervisor Walsh made a motion that the Town Board of the Town of Rosendale hereby authorizes the Supervisor to sign the proposal for a ductless split unit for the Rosendale Police Department in the amount of \$24,350.00 with Lowe Plumbing, Heating & Air Conditioning, Inc. Seconded by Councilmember Havranek; ROLL VOTE 4 Yes.
