WHEREAS, the Town Stormwater Officer, Mr. Nicholas Wulczyn with the assistance of the Town Consultant, Brinnier and Larios, P.C. has prepared a Draft MS4 Annual Report for the period of March 10, 2022 through March 9, 2023 (hereafter referred to as the 2022 MS4 Annual Report); nd

WHEREAS, the Draft 2022 MS4 Annual Report was made publicly available in printed form at the Town Hall at 1915 Lucas Avenue, Cottekill, New York 12419 and electronically available via the Town website since March 23, 2023.
