Supervisor Walsh made a motion to approve the minutes from the March 25, 2025 meeting; 2nd by Commissioner Stenta; Roll Vote: 2 Yes; Absent: Commissioner Hafner.

Correspondence: Sergeant Quigley said there were no correspondences received this month.

Chief's Report - Personnel: Sergeant Quigley said we hired Officer Barnhart as a part time officer. Supervisor Walsh made a motion to approve the hiring of Officer Barnhart; 2nd by Commissioner Stenta. Roll Vote: 2 Yes; Absent: Commissioner Hafner. Supervisor Walsh made a motion to hire Officer E. Normann as a permanent full time officer; 2nd by Commissioner Stenta. Roll Vote: 2 Yes; Absent: Commissioner Hafner. Supervisor Walsh made a motion to hire Officer A. Bassett to full time permanent officer; 2nd by Commissioner Stenta. Roll Vote: 2 Yes; Absent: Commissioner Hafner. Sergeant Quigley stated we they are in the process of conducting a background investigation on an individual to hire as a part time officer, and that person is a full time officer in the Town of Shawangunk.

Vehicles: Sergeant Quigley stated the new Blazer did come in and it is now being outfitted with the radios and lights then it will go to be lettered. This vehicle will replace 7F362.

Grants: Sergeant Quigley said she finished applying for the Police Traffic Safety Grant which is through the Governor's Traffic Safety Bureau which gives us extra patrols on the road and covers the officer's hours.

Department STATS: Sergeant Quigley said the calls for service is 928 year-to-date; 72 criminal cases; 31 arrests; 27 property damage auto accidents; and personal injury still remains at 2 and hasn't changed since last month. Sergeant Quigley said medical are at 49 calls. Sergeant Quigley said she looked into those a little more and 90% of the time we are getting there first and almost all are being transported to the hospital. Supervisor Walsh stated on May 9th there is a Public Hearing for the need for Marbletown Rescue for ambulance service for Rosendale and could the Chief submit a letter in support from the Police Department.

Training: Sergeant Quigley said Officer Normann attended a 3 day Dive Team training and is a Certified Diver. In-Service training is continuing until mid-May. Officer Fagerstrom attended the Wilderness Search & Rescue Training that we hosted here a few weeks ago.

Old Business: Sergeant Quigley had no old business.

New Business: Sergeant Quigley had no new business.
